A MESSAGE FROM THE PRESIDENT

I am pleased to present the Wentzville Police Department Blue Line Family, Inc.'s ("Blue Line Family") Annual Report, which details the organization's finances and administrative activities for the fiscal year ended December 31, 2024. This report provides an overview of where the Blue Line Family revenue comes from and where those dollars are spent.

2024 was a great year that had several changes to our exciting events which allowed us to do some great fundraising for our organization. We held our 1st Annual Bags & Bling Bingo which sold out within three days of posting tables for sale. We participated in Wentzville Days and the Wentzville Fall Festival and hosted our 1st Annual Blue Line Family BBQ at Progress Park.

Because of the continued support from people like you, the Blue Line Family raised nearly \$110,000 in 2024. Your paycheck contributions, donations, purchases, sponsorships, and volunteer time have allowed us to have a direct impact on the Wentzville Police Department employees and our community.

Here is a breakdown of our major fundraisers and donations from 2024:

1st Annual Bags & Bling Bingo - \$27,056 3rd Annual Sporting Clay Fundraiser - \$29,448 6th Annual Trivia Night/1st Blacklight Trivia- \$27,557 Wentzville Employee Paycheck Contributions - \$11,425 Merchandise Sales - \$3,881 Personal/Corporate/Non-Profit Donations - \$10,269

2024 was a year of some changes for our board, but I do want to thank former President Stephen Hill and former Vice President Jeffrey Skaggs for their hard work, time and devotion to the Blue Line Family Board of Directors.

In 2024, the Blue Line Family was able to provide immediate and discrete assistance to police officers, support staff, and their families of nearly \$8,000. We have also given over \$16,000 back to the Wentzville community through outreach programs such as food, gift cards, rent and utility assistance, and the purchase and donation of a facility canine, Winnie, for the Wentzville Police Department. Winnie's purpose is to help reduce anxiety, comfort officers and staff, encourage positive relationships with the community, and to enhance the well-being of Wentzville City employees. We contributed \$2,000 to the Wentzville Police Department's Shop with a Cop program and adopted four families for Christmas.

The Wentzville Police Department was lucky enough to suffer no major events requiring our direct intervention and assistance. We were able to continue a support role to officers and support staff and their families who had minor surgical or medical issues.

All of this is why we do what we do, giving up personal time, and putting in many hours of volunteer work. Your support makes it possible for us to immediately make a substantial impact on people who need it the most. Thank you for also putting your time and money into this organization. This is YOUR organization and it is here for you when and if you need it. Your generosity of time and money allows us to show our officers and support staff that our community truly supports each and every one of us.

ABOUT US

The Blue Line Family is a 501(c)(3) non-profit organization and acts as a support system for Wentzville Police Department officers and support staff and their families in times of need. All Wentzville Police Department officers and support staff are eligible to receive benefits by virtue of their employment with the Wentzville Police Department.

The Blue Line Family's Board of Directors and company officers developed the guidelines for the impartial distribution of funds to Wentzville Police Department officers and support staff and their families. The Board of Directors also determine the organization's mission and purpose, oversee the management of available resources, and organize and direct various fundraising activities.

HELPING EACH OTHER IN TIMES OF NEED

The Blue Line Family provides varying levels of financial assistance as well as other types of assistance to Wentzville Police Department officers and support staff and their families in the event of:

- death or severe injury while performing their official duties;
- death or severe injury outside of performing their official duties;
- a spouse or significant other (of long-term standing) suffers death or severe injury;
- a dependent suffers death or severe injury;
- an immediate family member suffers a death;
- a critical illness or significant surgery;
- a spouse, significant other (of long-term standing) or
- dependent suffers a critical illness or significant surgery.

COMMUNITY OUTREACH

Families and individuals in need in the Wentzville community are given assistance including but not limited to meals, gift cards for gas or groceries, and needed goods.

During the holidays, families in need are chosen to receive assistance, including but not limited to meals, gifts and general goods.




